

#### **ABOUT THE COURSE**

National and Sub-National governments face immense challenges to finance, implement and maintain infrastructure necessary to deliver and sustain basic services to their citizens and foster economic growth. Public-Private Partnerships (PPPs) are one tool that governments are increasingly employing to develop infrastructure and provide essential services.

The objective of this course is to equip the participant with a sufficient understanding of how PPPs can help to address the development



challenges faced in developing countries. The course is extensive in scope and intensive in depth. It seeks to deliver a 'full package' of a PPP in a record duration and at a fraction of what comparable service providers will charge for the 'full package'.

The course is designed and developed by CUEA CPD under the leadership of Mr Charles B G Ouma with assistance from our two lead faculty named below. It was developed in response to an unmet need in East Africa for a home-grown short course in PPPs that covers the entire length, breadth and depth of PPPs in duration that factors in the circumstances of the intended participant at a manageable cost.

In a learning environment comparable to few, a carefully selected panel of speakers explores various aspects of PPPs with sufficient depth to empower course participants to conceptualize and implement PPP projects at their respective work places or render advisory services concerning the same.

#### **INTENDED OUTCOMES**

This 2-week course brings together a diverse range of experts from academia, legal practice, government and the private sector to provide global perspectives and real-world experience to

give the participants a deeper understanding of PPPs. The course aims to give the participants an appreciation of the PPP project life cycle and the key issues and challenges a PPP presents, from project selection to implementation. Participants will be able to gain and apply their knowledge and understanding of PPPs to conceptualize, design, develop, and implement PPPs for a broad range of projects.

Through a judicious use of case studies, participants will learn about successes and failures in PPPs and from the success and failure stories, gain an understanding of when and why one might, or might not, chose to implement a PPP project.

#### **COURSE OBJECTIVES**

At the end of the course, participants will be able to:


- 1. Advice on the concept of a PPP and how a PPP can fill the financing gaps in infrastructure development
- 2. Structure, implement and manage a bankable PPP
- 3. Identify the challenges and opportunities presented by PPPs

- 4. Select the most appropriate projects for PPPs
- 5. Consider and respond to PPP proposals
- 6. Negotiate and draft PPP contracts

#### WHO SHOULD ATTEND?

PPPs are structured and implemented by a broad range of actors: policy makers, professional lawyers, and engineers, accountants, experts in finance, energy & utilities. The course content is multi-disciplinary in nature and public servants as well as private practitioners with an interest in PPPs will find the course responsive to their needs.

The course is practical in content and delivery method and an intended outcome of the course is that on successful completion of the course, course participants should be able to structure an actual PPP project or advice on the same. This course, like the many other courses designed by CUEA CPD pays meticulous attention to the identified needs of the potential participant and is flexible enough to accommodate the declared needs of the actual participants. It is therefore expected that participants will have a course experience to remember.

In 2007 he undertook an International Lawyers for Africa (ILFA) Scholarship Programme with Linklater's LLP, College of Law and Cambridge University in the United Kingdom and acquired extensive expertise in PPPs and PFIs within the United Kingdom Legal context. Crispine has experience in commercial transactions and Legal framework development including Structuring PPP Advisory in projects, Transaction Agreements, Contracts and Transactional Due diligence.

In the recent past Crispine has been involved in a number of PPP Projects, Regulatory Advisory and Corporate Financing Transactions including advising on the PPP Structuring for the proposed EAC Broadband Network (EAC-BIN), Advising Kenya Railways on the transaction design for the Standard Gauge Railway, Transaction Advisory to Kenya Electricity Generating Limited in the development of Olkaria II and IV Geothermal Projects, and Advisory to the Communications Commission of Kenya in the development of the Kenya Communications Regulations.

A dual U.S. and France-qualified lawyer, John is fluent in both English and French and has extensive experience working in both civil and common law jurisdictions. John has unique expertise in terms of (i) highly visible pilot projects (ii) representing IFIs, governments and multilateral lenders, (iii) emerging market related mandates, and (iv) "legal transition" and "policy" mandates.
